

Annexure I: Analysis of Feedback

1. Curriculum

Detailed syllabus is satisfactory as it is updated syllabus and the course contents are correlated with the degree.

2. Mode of Teaching

Modern teaching aids and technology are utilized for effective teaching in the classroom, however this facility should be provided in all the classes.

3. Infrastructure

Library, Reading Room, Computer lab and HRD lab. 86% students are feeling satisfactory with the existing facilities; however 14% students have suggested that little bit improvement should be made in it.

4. Co-Curricular Activities

All students and parents are highly satisfied with the co-curricular activities organized by the institution.

5. Counselling and Placement

All students and parents are satisfied with the counselling sessions held frequently by the institution. Students and Parents are also satisfied with the campus placement programmes by the institution. However very few students take the benefit of the placement activities, because they want to pursue the higher level studies in India and Abroad.

Annexure : II Best Practices

A: Title of the Practice: I. Remedial Coaching Classes

- Goal:

The aim is to provide help to the students in their academic progress. This practice is offered free to the students specially for SC/ST/OBC & Minority students. We also facilitate the students of open (general) category.

- The Context:

Our institute is a grant-in-aid institution and students come from rural background so there is great need to support the students financially as well as in education.

- The Practice:

Students are divided into subject-wise batches

- The classes are conducted before college time.
- Students are free to select the subjects of their choice.
- Students are guided by the faculty of the institute.
- Students are benefited in terms of improvement in the results.

- Evidences of Success: Improvement is observed in the results of the students.

- Problem encountered and Resources required:

We have not yet encountered any major problem. But Shortage of faculty members sometimes become hurdle, but any how we overcome it with the services of ad-hoc faculties. Most of students are commuting so they fail to take best possible advantage of the scheme.

B: Title of the Practice: II Eco- Club

- Goal:
 - To create awareness and a clean and green consciousness among the students of our institution towards critical issues like environment and conservation of natural resources.
 - It is a platform where we get knowledge about environment.
 - To promote not only the participation of students in the echo friendly system but to oversee the continuous improvement of the environment behaviour of organization and of society in general.
 - To coordinate, represent, manage and foster the common environmental interest without harming general environmental interest through future generation.

- The Context:
 - The continuous degradation of Mother Nature and dier need to sensitise the future generation the echo club is formed.
 - Surely it will promote genuine awareness, understanding, knowledge and participation of students.

- The Practice:
 - For the first activity “Best out of Waste” not only members of the club but all the students of the college were asked to bring waste raw materials (old news papers and other waste papers) from their home.
 - Few members of the club knew how to make paper bags so training programme was organised and 15 students were trained.
 - NSS volunteers were asked to collect raw materials from the village.
 - This time small bags for vegetable and fruits vendors were made. So that they would not use plastic bags for strips and bottles.

- Evidences of Success: Improvement is observed in the results of the students.
 - This activity brought awareness of conservation of natural resources among volunteers.
 - Some creative volunteers also made beautiful gift articles like pen stand and flower vas and those articles were given as gifts to the guests during valedictory function.
 - Out of waste hard board and card board Dustbins of different sizes were made and they were gifted to two schools.

- Problem encountered and Resources required:
 - Initially students were not attracted but once they get involved in the activities they found it very interesting.
 - For getting resources we did not face many problems because students and staff members brought waste papers from their homes.
